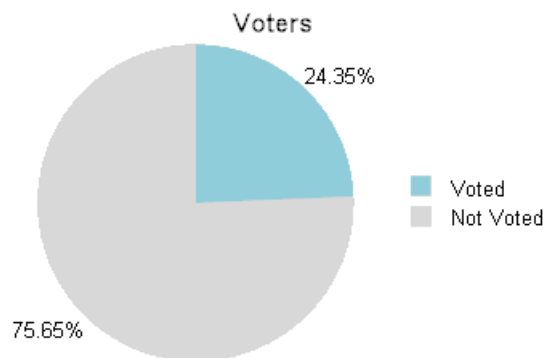

The following ballot report is for Ballot for the election of Councillors – South Australia conducted by TrueVote on behalf of Australian Conservation Foundation Incorporated. The ballot was open from 28/08/2015 to 25/09/2015.

Voter Roll

The voter roll for the ballot consisted of 727 registered voters. 177 registered voters responded to the ballot notification sent out by TrueVote.

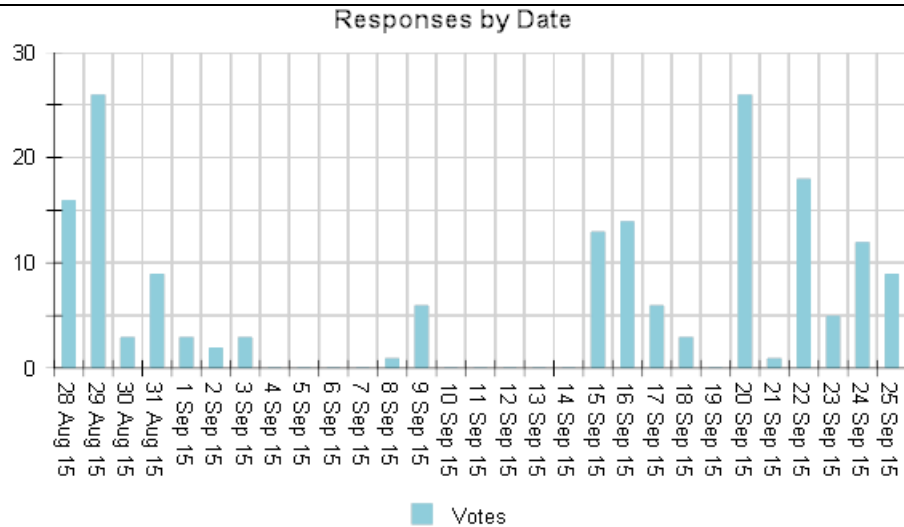
