## ACT OF PARLIAMENT

### Proclamation

I, John Landy, Governor of Victoria, declare that I have today assented in Her Majesty's name to the following Bill:

No. 2/2003 **Constitution (Parliamentary Reform) Act 2003**

- No. 2/2003
- (1) This Part comes into operation on the day on which this Act receives the Royal Assent.
  - (2) Subject to sub-section (4), Divisions 1, 3 and 4 of Part 2, Division 1 of Part 3 and Division 1 of Part 4 come into operation on a day to be proclaimed.
  - (3) Division 2 of Part 2, Division 2 of Part 3 and Division 2 of Part 4 come into operation on the day of the dissolution or other lawful determination of the Legislative Assembly next occurring after the day on which this Act receives the Royal Assent.
  - (4) If a provision referred to in sub-section (2) does not come into operation before 1 January 2004, it comes into operation on that day.

## **Constitution (Parliamentary Reform) Act 2003**

### PROCLAMATION OF COMMENCEMENT

I, John Landy, Governor of Victoria, with the advice of the Executive Council and under section 2(2) of the **Constitution (Parliamentary Reform) Act 2003**, fix 8 April 2003 as the day on which Divisions 1, 3 and 4 of Part 2, Division 1 of Part 3 and Division 1 of Part 4 of that Act come into operation.
